KMFCU will award up to three \$1,000 scholarships to graduating high school seniors who plan on pursuing an advanced education in 2022 at a college or trade school.

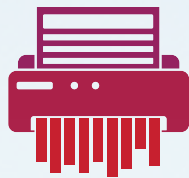
The requirements are:

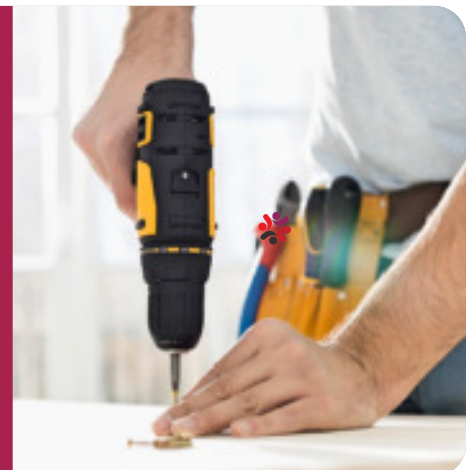
We are going green!
