This is the official notification to members of the annual meeting to be held on **March 28th, 2023**. The business meeting will convene at 9:30 a.m. The meeting will be held at Kellogg Midwest Federal Credit Union, 9618 Brentwood Drive LaVista NE, 68128. **Tickets will be available to purchase from March 1st – 7th.**

Per Article IV, Section 2, of the Bylaws of Kellogg Midwest Federal Credit Union, notice is hereby given that there will be an election of one (1) Director to the Board of Directors of Kellogg Midwest Federal Credit Union for a three (3) year term. The election will be conducted by Ballot and there will be no nominations from the floor.

Any member interested in running for a position on the Board of Directors of Kellogg Midwest Federal Credit Union should submit a petition signed by at least 10% of primary membership (currently 294 signatures). Qualifications to be considered include, but are not limited to the following: Must be a member in good standing, must be 19 years of age, must be bondable, must not have delinquent loan history, and must have good credit. The closing date to receive nominations by petition shall be 5:00 p.m., February 8, 2023. All candidates will be posted on or by February 17, 2023. **The election will not be conducted by ballot as long as the number of Nominees equals the number of Board positions (1) up for election.**
